

Dependent Verification Checklist

Below is a list of eligibility rules and documents required to verify your dependent(s). In most cases at least TWO forms of documentation are required for dependents. Please read carefully.

Document Option for Verifying Eligibility:

Government Issued Marriage Certificate AND Federal Tax Return Within Last 2 Years

OR

Government Issued Marriage Certificate AND Proof of Joint Ownership (i.e. Lease Agreement, Mortgage, Utility Bill, etc.) Issued Within Last 6 Months

OR

Government Issued Marriage Certificate Only (if married in the last 12 months)

Document Options for Verifying Eligibility:

Affidavit of Common Law Marriage AND Proof of Joint Ownership Issued Within Last 6 Months

OR

Affidavit Of Common Law Marriage AND Federal Tax Return Issued Within Last 2 Years

DP	Domestic Partner	Age 18 and over- Same/Opposite Sex	<ul style="list-style-type: none"> • You and your DP are at least 18 years of age and capable of consenting to the relationship • You and your DP are not related to one another to a degree that would prevent marriage under the laws of the state you reside in • Neither you nor your DP is married to another person under statutory/common law or in another DP relationship • You and your DP have been in a single, dedicated relationship for a minimum of 6 consecutive months • You and your DP share the same residence for a minimum of 6 consecutive months

Document Options for Verifying Eligibility:

Proof that you and your partner have resided together for at least six (6) months (i.e. Lease Agreement, Mortgage, Utility Bill, etc.) AND Registration as a domestic partner in the municipalities that have established such a procedure (New York City, Rochester, Ithaca, etc.)

OR
 Proof that you and your partner have resided together for at least six (6) months (i.e. Lease Agreement, Mortgage, Utility Bill, etc.) AND Proof of Financial Interdependence (i.e. Bank Statement, Tax Return, etc.)
