VI. RESOLUTION

WHEREAS, the Board of Education of the Averill Park Central School District ("District") maintains as fleet of school buses for student transportation purposes; and

WHEREAS, the District's bus fleet travels nearly one million miles a year; and

WHEREAS, the average useful life of fleet buses, due to terrain traveled and Northeast weather conditions, is about 10 years with each bus in the Fleet logging approximately 90,000-130,000 miles over that time; and

WHEREAS, the Board of Education is committed to a regular and systematic fleet replacement plan which requires an annual bus purchase vote for bus replacement and is an essential component of maintaining student safety and minimizing fleet repair and maintenance costs; and

WHEREAS, the Board of Education also desires to maintain healthy, safe and reliable facilities and grounds; and

WHEREAS, the Board of Education acknowledges that to do so requires efficient, effective and operable equipment to maintain the District's facilities and grounds;

THEREFORE, BE IT RESOLVED, by the Board of Education of the Averill Park Central School District, Rensselaer County, New York that a proposition be put forth to address the District's bus and equipment requirements as follows: Section 1. The proposition set forth below is hereby authorized to be submitted for the approval of the qualified voters at the annual budget vote and election to be conducted by voting machine on the 18th day of May, 2021, between the hours of 7:00 a.m. and 9:00 p.m., prevailing time, in the High School Auxiliary Gym, in said School District. Section 2. The School District Clerk is hereby authorized and directed to include as a part of the notice of the annual budget vote and election the following regarding said proposition:

NOTICE IS HEREBY FURTHER GIVEN that at said annual budget vote and election the following proposition will be submitted: School Bus & Equipment Purchase Shall the Board of Education of the Averill Park Central School District, be authorized (a) to purchase nine (9) school buses at a cost not to exceed \$780,763, and one (1), rack/plow truck at a cost not to exceed \$53,711; (b) expend such sums for such purposes; (c) levy the tax necessary therefore, to be levied and collected in such amounts as may be determined by the Board of Education taking into account state aid and trade-in or resale value

of existing equipment received; and (d) in anticipation of the collection of such tax, to issue bonds and notes of the District at one time or from time to time in the principal amount not to exceed \$834,474, and to levy a tax to pay the interest on such obligations when due?

WHEREAS, the Board of Education of the Averill Park Central School District ("Board") is considering to undertake a project involving repairs, upgrades, and renovations to its existing facilities at the Algonquin Middle School addressing building-wide electrical system improvements, more specifically involving repairs and upgrades to the fire alarm system and any related work ("the Project"); and

WHEREAS, the Board wishes to fully comply with its obligations under the State Environmental Quality Review Act ("SEQRA") and the regulations thereunder with respect to the proposed action; and

WHEREAS, the Board has carefully considered the nature and scope of the proposed action; and

WHEREAS, upon review of the foregoing, the Board makes the following determinations:

- 1. The proposed action involves repairs, upgrades, and renovations to existing facilities at the Algonquin Middle School addressing building-wide electrical system improvements, more specifically repairs and upgrades to the fire alarm system and any related work ("the Proposed Action" or "Project").
- 2. The proposed project represents maintenance or repair involving no substantial changes in an existing facility or structure within the meaning of 6 NYCRR 617.5(c)(1); and/or alternatively the replacement, rehabilitation or reconstruction of a structure or facility in kind within the meaning of 6 NYCRR 617.5(c)(2).
- 3. The proposed action will in no case have a significant adverse impact based on the environment based on the criteria contained in 6 NYCRR § 617.7(c), and is not otherwise a Type I action as defined by 6 NYCRR § 617.4.
- 4. The proposed action is a Type II action within the meaning of 6 NYCRR 617.5 and is therefore not subject to review under SEQRA and the regulations thereunder.

NOW THEREFORE BE IT RESOLVED that the Board finds and concludes that the proposed action is a Type II action within the meaning of 6 NYCRR 617.5 and therefore is not subject to review under SEQRA and the regulations thereunder.

IT IS HEREBY RESOLVED THAT any prior actions of the Board approving Regulations associated with policies are hereby rescinded as Regulations are the province of the Superintendent to promulgate and implement. The Board's approval of any prior policies remain valid and any future action will be on policies only.

XII. Resolution to approve Higher Risk Sports

WHEREAS, on January 22, 2021, the Governor and the New York State Health Department authorized schools to operate certain Higher Risk Sports effective February 1, 2021 as may be permitted and authorized by local county health departments; and,

WHEREAS, the New York State Department of Health subsequently issued updated guidelines for the operation of Sports and Recreation related to Higher Risk Sports; and,

WHEREAS, NYSPHSAA and Section 2 have issued revised guidelines for Return to Interscholastic Athletics for the 2020-21 season: and,

WHEREAS, on January 28, 2021 Rensselaer County Executive Steven F. McLaughlin and Public Health Director Mary Fran Wachunas approved schools within Rensselaer County to operate Higher Risk Sports should schools wish to participate in one or more Higher Risk Sports; and,

WHEREAS, the Superintendent of Schools has shared with the Board the plan to provide Higher Risk Sports in accordance with all applicable New York State Department of Health, Rensselaer County Department of Health, and any applicable league health and safety requirements which will be implemented during all practices and games.

IT IS THEREFORE RESOLVED THAT, upon the recommendation of the Superintendent of Schools, the Board of Education of the Averill Park Central School District hereby approves the following:

- 1. Implement the following interscholastic sports for the 2021 Spring season:
 - Participate in athletic competitions in the following sports/levels:
 - Boys Lacrosse (M/JV/V)
 - Skill development sessions and intra-squad only scrimmages in the following sports/levels:
 - Unified Basketball (JV)
 - Practices, skill development sessions and/or non-contact training/workouts will begin on May 2, 2021 or as soon thereafter as practicable.
