- 2. AMS Grade 7 Beginning Balance is from 17/18 not 18/19. Ledger is missing December transactions. No proper paperwork included, no invoices, statements of revenue or minutes from meetings. Advisors listed as Toni Conover and Michael Cavotta no response in regards to my letter sent.
- 3. AMS Yearbook Ledger only submitted account has a CR dated 8/5/19 but not recorded on the ledger because she used the balance as of 9/1 for her ledger not 7/1. No other documentation was submitted and no other activity. Per prior year info activity usually starts around February or March for yearbook sales. Will keep an eye on during the year and address as necessary. Advisors listed as Carol Winkley and Joanne Goodermote.
- 4. Class of 2020 Balance discrepancy due to CR #6356 not on club ledger. Sales Tax vendor credit not on club ledger (posted December teachers already gone for break) and check request submitted but not processed. Advisor listed as Nicole Freeman after speaking with her she is going to update her ledger and compare her records to ours on a more consistent basis.

Advisors listed as Jen Yost and Ann Medici. I have spoken with Jen and we are working on a plan so she is aware of proceeds from other clubs.
- 6. Drama Sales Tax vendor credit not recorded (posted 12/20/19 teachers already gone for break). No club meeting minutes submitted. Advisors listed as Lauren Mouzakas and Sarah Christy.
- 7. AMS Grade 8 No paperwork or binder submitted to Audit. **Update** paperwork submitted week of January 6th after audit was completed. Reviewed binder to see that as of 1/15/2020 this club has had no activity this 19/20 school year and no meeting minutes. Advisors listed as Chris Anderson and Holly Gardinier. After further review club acitivity usually starts around February or March. Will keep an eye on during the year and address as necessary.

- 8. National Honor Society No paperwork or binder submitted to Audit. **Update** paperwork submitted 1/16/2020. Dry cleaning receipt needs to be a detailed receipt of what was cleaned. Advisor listed as Karyn Rees, Alice spoke with Karyn and was able to get a detailed receipt.
- 9. Horticulture No activity for 19/20 school year as of 12/20/2019. Advisor listed as Elena Oldendorf. After further review club activity usually starts around February. Will keep an eye on during the year and address as necessary.
- 10. Japan No paperwork or binder submitted to Audit, No activity on club and no advisor appointed HS principal contacted. Prior year Advisor was Susannah Graziano. Per Heath Quiles a memo is being processed to close the account.
- 11. MH KKIDS Only submitted a ledger sheet no copies of invoices, statements of revenue, memos or minutes of meetings. Missing sales tax vendor credit (posted December teachers already gone for break) and missing bank deposit adjustment posted in November. No officers appointed. Advisors listed as Andrea Lubbers, Tara Russell, Sally McKenna and Bethany Reddy. Spoke with Andrea and discussed the process of comparing her ledger to our records and she is going to correct going forward.
- 12. PES KKIDS Missing proper documentation, no copies of statement of revenue, minutes from meetings, and missing student signatures on documentations provided. Ledger is inadequate proper deposit amounts not posted to reflect tax. Missing sales tax vendor credits, incorrect beginning balance and 4 checks requested not listed on ledger. Advisors listed as Julianne Strano and Jaclyn Sgambati.
- 14. MUSIC Ledger is missing a November deposit and has a deposit posted for the incorrect amount. Missing copies of proper paperwork and signatures for invoices, statements of revenue, memos etc. Club has 2 student treasurers appointed and no other club officers and does not have meetings. Advisor listed as Michael Blostien. Spoke with Michael and is correcting his paperwork going forward.
- 15. New Horizons Ledger does not include a check request, deposits are not posted to reflect the sales tax. Missing sales tax vendor credit (posted December teachers already gone for break) and proper paperwork (copies of invoices, statements of revenue, memos). Advisor listed as Jay Goodnow

- 16. Odyssey of The Mind No paperwork or binder submitted to Audit. Advisor listed as Dan Fairchild. Spoke with Dan and he is a new advisor this year explained to him what is required and what he needs to correct and provided the NYS Pamphlet 2 to him.
- 17. Robotics No paperwork or binder submitted to Audit. **Update** paperwork submitted week of January 6th. Reviewed the paperwork there are no copies of any deposits made or invoices paid. Ledger has a discrepancy of a check paid that we do not have in our system. Advisors listed as Kierstin Lambright and Matt Duff.
